Application for Registration

In order to register as an eligible Aboriginal supplier, applicants must satisfy the following criteria:

- The business must be located and operated in Saskatchewan.
- The business must be registered as a legal entity with Saskatchewan Justice, Corporations Branch.
- The business must be considered to be an Aboriginal owned Business.

An Aboriginal business is defined as:

- a band as defined by The Indian Act operating a business or providing a service; or
- a sole proprietorship owned and operated by a Status Indian, non-Status Indian, Metis or Inuit person(s);

Or

- a limited company, a co-operative, a partnership, a not-for-profit organization in which Aboriginal persons have at least 51 percent ownership.
- A joint venture consisting of two or more Aboriginal businesses or an Aboriginal business and a non-Aboriginal business(es), provided that the Aboriginal business(es) has at least 51 percent ownership.
